5.	Issues 1 and 3 seem slightly incoherent. Are those supposed to be the same?	j

In view of the fact that Dhall is a separate country altogether and the region affected by the impugned activities of Kartina is located outside the territorial limits of Kartina, in such circumstances, citizens of Dhall have no locus to claim any protection of Fundamental Rights enshrined in the Constitution of Kartina. Therefore, the 3rd issue has nothing to argue upon from the side of Dhall thus whether the third issue as given in the Moot Proposition requires any alterations or not? Constitutional claims being settled or dealt with by River Dispute Tribunals, that too when the dispute is between two countries is not the norm followed in judicial proceedings?
