The first Surana & Surana UPES School of Law National Insolvency Law Moot Court Competition was held in 2018 in association with esteemed joint organizer Surana & Surana International Attorneys, Chennai & New York. The competition was organized from September 28, 2018, to September 30, 2018. Hon'ble Justice U.C. Dhyani, Chairman of the Public Service Tribunal in Dehradun and a former judge of the Uttarakhand High Court in India, attended the inaugural ceremony. Dr. Vinod Surana, CEO and Partner of Surana & Surana International Attorneys, Chennai & New York, served as the valedictory ceremony's chief guest. ### **RULES OF THE COMPETITION**

#### T AIM AND PURPOSE

The Surana & Surana and UPES School of Law's National Insolvency Law Moot Court Competition aims to facilitate understanding of evolving jurisprudence in Insolvency Law emerging trends. It also focuses on enhancing research, writing, and advocacy skills. By participating in this competition, individuals have the opportunity to enhance their legal acumen and contribute to the growth of this specialized field.

### **II DEFINITIONS**

- 1. Advanced Rounds: It shall refer to the Octa Final, Quarter Finals, Semi Finals, and a Final Round of The Competition. Octa Final rounds shall be conducted at the discretion of Organisers, if the Registration exceeds 30 Teams.
- 2. Competition: It shall refer to the VIIth edition of the Surana & Surana and UPES School of Law, National Insolvency Law Moot Court Competition, 2024.
- 3. Disqualification: It shall render a team invalid to continue participating in the Competition.
- 4. Judge: It shall refer to any person appointed to evaluate a Participant's Memorial or Oral Pleading.
- 5. **Memorial**: It shall refer to the written arguments submitted by each team, on behalf of both the Parties, according to the official competition rules.
- 6. National Administrator: It shall refer to the Dean, School of Law, UPES (Chairman, Moot Court Association, UPES).
- Oral Rounds: It shall refer to a team's pleadings, composed of both speakers, submitted orally in front of the judges, on behalf of one of the parties, against another team representing the opposing party.
- **Parties**: It shall refer to the parties to the dispute as identified by the case record as 8. Informant/ Appellant and Opposite Party/Respondent.
- Penalties: It shall refer to points deducted for violation of any Rules mentioned 9. hereunder.



**NOTE:** The organizing committee reserves the authority to disqualify any team if there is any grave violation of these Rules.

- 10. **Preliminary Rounds:** It shall refer to the Oral Rounds which will take place prior to the Advanced Rounds of the Competition for the purpose of determining the teams which will proceed to the Advanced Rounds.
- 11. **Rules**: It shall refer to these official Competition Rules and such other applicable supplements to these Rules published by the Organizing Committee.
- 12. Organizing Committee: Shall mean and include members mentioned in brochure.
- 13. Scouting: It shall refer to the act of attending a round in which the members of the team or any person related to the team are not competing.
- 14. **Team Code**: It shall refer to the unique number allotted to each participating team for the purpose of this Competition. This would primarily be used for all submissions of memorials.
- 15. **Competition Code**: For the oral rounds based on the fixtures competition codes will be allotted through a draw of lots as part of the orientation.

### III VENUE AND DATE

Surana & Surana and UPES School of Law National Insolvency Law Moot Court Competition shall be held in Hybrid Mode, The virtual rounds will take place on 10th August, 2024 and offline rounds will take place from the 6th September, 2024-7th September, 2024 in the Kandoli Campus of University of Petroleum and Energy Studies.

### IV **LANGUAGE**

The competition shall be conducted in the English language.

### V <u>ELIGIBILITY</u>

The competition is open for students who are pursuing LLB (three-year / five-year) courses during the current academic year.









#### **TEAM COMPOSITION** VI

The maximum number of participants per team shall be restricted to 3 wherein only 2 shall be speakers and 1 shall be the designated researcher. The researcher shall be allowed to argue with the prior permission of the court and National Administrator in case of illness of the designated speakers.

Note: Only the designated speaker in the Preliminary Rounds shall be eligible for the Best Advocate award.

- 2. No Team Coach, mentors, observer or any other person shall be accompanying registered participating team members.
- 3. Teams should not disclose the identity of their institution; such disclosure shall invite penalties including disqualification. The decision for the same shall be at the discretion of the National Administrator.

#### REGISTRATION

#### • Provisional Registration

- 1. Provisional Registration commences from 26th June 2024.
- 2. The Provisional Registration shall be done by 7th July 2024. It is mandatory for every university to register provisionally via its moot court's ID at LINK.
- 3. Teams will receive confirmation mail of the successful provisional registration from the Host University.

#### **Final Registration**

- 1. Final Registration for teams commences from 26th June 2024
- 2. The teams must register online by 20th July 2024. Teams will have to register online at <u>www.moot.in</u>
- After registering online, the teams must complete the Registration Process as stated below by sending a copy of the documents for authentication, at mootcourt@ddn.upes.ac.in
- Participants will receive approval as acceptance of their request for participation within 2 days from the last date of registration.









#### • Authenticated Documents

The following documents are required by the teams at the time of Final **Registration**:

- 1. An external participation form / approval letter (with seal and signature) as provided in the rules (refer to page no.31 duly filled from the participant's institution / moot society.
- 2. Scanned copy of the receipt of online payment.

Note: Signatories on the registration form should be any of the following: Faculty- in charge of MCA / MCS / MCC, Registrar, Dean, Principal, Director, Vice-Chancellor.

#### • Registration Fee

A registration fee of Rs. 3,500/- (Three Thousand Five Hundred rupees only) is to be paid online by the team through Net Banking for online rounds only. Additional amount for advance rounds (including accommodation, transport, food etc) is Rs. 3,000/- (Three Thousand rupees only).

- Teams may seek clarification latest by **22nd July 2024 (11:59 PM IST)** through the following <u>Google Form</u>.
- 2. All the clarifications shall be posted on <u>www.moot.in</u> and emailed to all the participants on their respective email-ids provided in the registration form by **24th July 2024**.

#### IX WRITTEN SUBMISSION

- 1. Each Team is required to prepare Written Submissions for both sides, i.e., the Applicant(s)/Claimant(s)/Petitioner(s) and the Respondent(s) of the case. A Written Submission shall be identified solely by the Team Code assigned to the Team under the Rules of the Competition. The Written Submissions shall not, in any way, disclose any fact about the Identity of the Team, its members, or the Institution/College/University represented by the Team.
  - The cover page of the Claimant's memorial should be Blue for the Applicant(s)/Claimant(s)/Petitioner(s) and Red for the Respondent.
    - The soft copy of the Memorials for the Applicant(s)/Claimant(s)/Petitioner(s) and the Respondent should be submitted in a zip folder on <u>LINK</u> and also to email to <u>mootcourt@ddn.upes.ac.in</u> and <u>ai@lawindia.com</u> on or before **30th July 2024** (11:59PM IST). Late submissions will be penalized by one point each per memorial for every hour of delay.
    - Once the soft copy of the memorials have been submitted, no revisions, supplements, or additions will be allowed.
    - The submissions shall be the original work of the team. The similarity (Plagiarism) for a Memorial should not be more than 15%.
  - The teams are requested to submit 8 hard copies of memorials of both sides (only for the offline rounds) on **5th September 2024** on the registration desk.
    - The memorials shall be submitted in Word format as well as PDF Format. The file shall be named as "Team Code- Appellant" and "Team Code- Respondent" respectively. Once the soft copy of the memorials has been submitted, no revisions, supplements, or additions will be allowed.







8. A Written Submission shall consist of the following mandatory heads:

- A. Cover Page
- B. Table of Contents
- C. List of Abbreviations
- D. Index of Authorities
- E. Statement of Facts (not exceeding 2 pages)
- F. Issues Raised
- G. Summary of Arguments (not exceeding 2 pages)
- H. Arguments Advanced (not exceeding 30 pages)
- I. Prayer (not exceeding 1 page)
- 9. The Cover Page of a Written Submission must contain the following information:
  - A. The Team Code in the upper right-hand corner in accordance with the Rules of the Competition.
  - B. The name of the case
  - C. The side for which the Written Submission has been prepared
  - D. Name of the forum resolving the dispute.
- 10. Teams shall cite all authorities in the Written Submission using footnotes as per Bluebook (21st Edition).
- 11. The Written Submission shall not contain any annexures, photographs or any other representation of nature.
- 12. The Written Submission (including the preliminary pages and excluding the cover page) shall adhere to the following mandatory specifications:
  - A. Paper size: A4
  - B. Font type: Times New Roman
  - C. Font size: 12
  - D. Line spacing: 1.5
  - E. Body of text: Justified
  - F. Margin: 1 inch on all sides
  - G. Page Numbering: Top right side of each page
- 13. For footnotes, the formatting specifications are:
  - A. Font type: Times New Roman
  - B. Font size: 10
  - C. Line spacing: 1
  - D. Paragraph spacing: 0
  - E. No additional space between 2 footnotes
  - F. Body of text: Justified









14. The identity of the institution shall not be revealed anywhere in the memorial. Violation of this provision shall result in penalties including disqualification. The Organizing Committee's decision shall be final.

#### Χ **COMPENDIUM**

- Teams are required to submit their compendium at the mootcourt@ddn.upes.ac.in 1. via email to Moot Court Association. Only then will they be allowed to present it during the rounds. Teams can present their compendium via screen-sharing during the virtual rounds and physically during the offline rounds.
- In case of failure of a team to submit a compendium to the organizing committee, 2. the team shall not be allowed to share the compendium with the bench.
- Any identifying marks/seal of the college shall attract severe penalties including disqualification. There will not be any passing of notes to the judges. The compendium will have to take care of this requirement. The teams can take them back after the respective rounds.
- It is not mandate for the teams to make the compendium. However, if a team is 4. making one then they are required to submit the submit via mail by 30th July 2023 (11:59 PM).

#### XI <u>ROUNDS</u>

There will be two Preliminary Rounds which will be held Virtually, a Octa Final, Quarter-final, a Semi-Final, and a Final Round which will be conducted Offline at the campus of UPES Dehradun. Octa- Final rounds would be conducted only at the discretion of the organising commitee depending on the number of teams.

Octa Final Rounds will be conducted if the Registration exceeds 30 Teams.

- Preliminary Round (Virtual Mode) 1.
  - 1.1. There will be two preliminary rounds of arguments per team, once on behalf of the Claimant and another on behalf of the Respondent in online mode on 10th August 2024.
  - 1.2. No team shall appear before each other more than once in the Preliminary Rounds.
  - 1.3. Each team will face a different bench of judges in their second round of arguments.
  - 1.4. Each team will get a total of 30 minutes to present their case. This includes time for rebuttals.









- The division of time is at the discretion of the team members, subject to a minimum 1.5. of 15 minutes per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
- 1.6 The researcher shall sit with the speakers at the time of the Oral Rounds.
- 1.7 Extension of time will be allowed only at the judges' discretion.
- 2. Octa Final Rounds (Offline Mode)
  - 2.1. Octa finals will be held offline at UPES Dehradun Kandoli Campus.
  - 2.2. Octa finals will be held on 6th September 2024, and the top 16 (Sixteen) teams will qualify for the Octa finals.
  - 2.3. Each team will get a total of **30 minutes** to present their case. This includes time for rebuttals.
  - 2.4. The division of time is at the discretion of the team members, subject to a minimum of 15 minutes per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
  - 2.5. The researcher shall sit with the speakers at the time of the Oral Rounds.
  - 2.6. Extension of time will be allowed only at the judges' discretion.
- Quarter Final Rounds (Offline Mode)
  - 3.1. Quarter Finals will be held offline at UPES Dehradun Kandoli Campus.
  - 3.2. Quarter-finals will be held on 6th September 2024, and the top 8 (Eight) teams will qualify for the Quarter Finals.
  - 3.3. Quarter-Final & Semi-Finals will be knockout rounds.
  - 3.4. Each team will get a total of 45 minutes to present their case. This includes time for rebuttals.
  - 3.5. The division of time is at the discretion of the team members, subject to a minimum of 20 minutes per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
  - The researcher shall sit with the speakers at the time of the Oral Rounds. 3.6.
  - Extension of time will be allowed only at the judges' discretion. 3.7.
  - Semi-Final Rounds (Offline Mode)
    - 4.1. The Semi-Final Rounds will be held on 6th September 2024. The pairing of Teams for the Semi-Final Rounds shall be done by a draw of lots/power matchups.
    - 4.2. Each team will get a total of 45 minutes to present their case. This includes time for rebuttals.









- 4.3. The division of time is at the discretion of the team members, subject to a minimum of 20 minutes per speaker. Division of time shall be informed to the court officer/moderator before arguments begin.
- 4.4. The researcher shall sit with the speakers at the time of the Oral Rounds
- 4.5. Extension of time will be allowed only at the judges' discretion.
- 5. Final Round (Offline Mode)
  - 5.1. The Final Rounds will be held on 7th September 2024. The sides for the final rounds will be determined by a draw of slots.
  - 5.2. Each team will get a total of **45 minutes** to present their case. Further 5 minutes for rebuttal and sur-rebuttal. (Total time for each team =  $\overline{45+5}$ ).
  - 5.3. The division of time is at the discretion of the team members, subject to a minimum of 25 minutes per speaker. Division of time shall be informed to the court officer/ moderator before arguments begin.
- 6. Results
  - 6.1. The Final result and the winners of the various categories will be announced only during the valedictory ceremony on 7th September 2024.

### XII <u>DRESS CODE</u>

The dress code for the competition shall be as per the Bar Council of India Rules for Advocates.

### XIII SCOUTING

- Teams will not be allowed to observe the oral rounds of any other teams. Scouting is strictly prohibited. Scouting by any of the team members shall result in disqualification.
- In the virtual format, the presence of any team member in the virtual courtroom of any 2. other team except their own will qualify as Scouting.







#### ANONYMITY XIV

Student counsel may introduce herself/ himself to the court through their Competition Codes and sides represented. However, the team's college/ institution affiliation may not be mentioned at any time before the Valedictory Ceremony. Further, all team members, coaches, advisors, and observers shall refrain from identifying a team's school at any time and in any manner, including, but not limited to, wearing any identifying items, such as school clothing, ties, patches, or pins or carrying identifying material (such as a book with a college logo, or college).

#### XVI POLICY FOR VIRTUAL ROUNDS

- The Oral Rounds for the Preliminary Rounds will take place virtually via the Google 1. Meet platform.
- It would be the responsibility of every team to ensure a stable internet connection. 2. The audio and video of every member of the team should be clear. Every team must ensure a proper background. The organizers will under no circumstances be obligated to provide the participants with any such facility.
- All participants should mandatorily join with their laptops or desktops and other 3. forms of devices are to be avoided.
- The link for the room on the platform will be conveyed to the participating teams before the oral rounds.
- Each team is required to join the room at least 20 minutes before the scheduled time 5. of commencement of the oral rounds.
- The participants' camera and microphone shall be firmly positioned throughout the 6. oral rounds to show speakers and to ensure their voices are audible.
- All participants must keep their cameras on at all times during the rounds. The camera can be switched off in case of technical glitches with the permission of the bench.
- At the time when one participant is speaking, others are expected to keep their 8. microphones on mute.
- In case a participant is found disturbing the other pleader anyway, he/she or the entire team to which such participant belongs may be disqualified upon the discretion of the bench.
- Each participant is responsible for finding a suitable venue and background to 10. participate. The venue must be a quiet location and one which has adequate and reliable internet connectivity and has a desk and chairs for the oralist. Locations in open spaces or hallways or cybercafes or similar areas are NOT permitted.
- Participants are cautioned to ensure that all equipment has a power supply 11. sufficient to last or at least two hours without interruption.



- 12. In case of a loss in internet connection, each team will be given a reasonable time to reconnect. If the problem persists the decision made by the organizers shall be final and binding.
- 13. If one or both of the speakers cannot join due to connectivity issues, the team may be disqualified from the competition, and under no circumstances can another member of the team be allowed to switch roles.
- 14. Where a team does not appear within 10 minutes of the scheduled time for the round, the round shall proceed as ex-parte.
- 15. Any compiled Research Material (Compendium) or other supplementary documents may be, as per the discretion of the bench, presented by the team by using the "screen sharing" option given they have fulfilled to submit a soft copy via mailing it to the official mail id of the moot court association.

#### XVII <u>FINALITY</u>

- 1. The decision of the judges shall be final and binding regarding the oral rounds and memorial submissions.
- 2. In the case of any conflict regarding the composition of the team, the decision of the National Administrator will be final.
- 3. In the case of a gross misdemeanor, the decision of the Organizers in consultation with the judges will be final.
- 4. In the case of conflict regarding a situation outside the scope of the rules, the decision of the Organizers will be final.
- 5. The Administrator retains the right to amend the rules of the competition at their discretion, with the concurrence of the National Administrator.

#### XVIII <u>RESEARCHER'S TEST</u>

- 1. The Researcher's Test shall be conducted on 9th August 2024 via the Online medium.
- 2. The participant shall ensure complete integrity and shall not resort to unfair means while attempting the test. Any such attempt shall result in disqualification.
- 3. Necessary Details will be mailed to the respective team members after their Soft Copy Submission.
