

**OFFICIAL RULES FOR THE SURANA & SURANA INDIA NATIONAL ROUNDS OF  
THE 26<sup>TH</sup> STETSON INTERNATIONAL ENVIRONMENTAL  
MOOT COURT COMPETITION – 2021 – 22  
11 – 13 February 2022**

The Surana & Surana India National Rounds Will Be Conducted Virtually (Online). The National Administrator Reserves The Right To Modify Or Supplement The Rules For Any Reason.

1. These rules (modified to an extent from the rules of International rounds) shall be the official rules for the Surana & Surana India National Rounds of the Stetson International Environmental Moot Court Competition – 2021 - 22. The India National rounds rules are complementary to the International Rules. Details not specifically mentioned may be referred from the International rules.
2. However, for the World Finals the top teams advancing to the International Finals from India National Rounds are guided by the INTERNATIONAL RULES ONLY. The said rules may be downloaded from <http://www.stetson.edu/law/international/iemcc/index.php>
3. The 2021 - 22 Stetson (India) will have a single National Round. The competition will be held in **English language**.

<b>11th – 13th February, 2022 (Friday, Saturday &amp; Sunday)</b> (Day 1) - Registration, orientation and draw of lots, (Day 2) - Preliminary round- 1, Preliminary round-2, Octa finals (will be held if registered teams are 24 and above) & Quarter Finals (will be held if registered teams are 16 & above) (Day 3) - Semifinals (forenoon), Finals (afternoon) followed by valediction.	

**5. Team Composition**

- a. Each team can have two speakers and one researcher. Not more than two additional members (total 5) may be part of a team. Additional members will not participate in the proceedings. All members will be awarded participation certificates. **Additional members will be given only participation certificates, even if their teams win in any category.**
- b. Team Participating in the India National Rounds from the Host School will be guided by Rule **B. 2** (a – d) of the International Rules.
- c. **IMPORTANT** – Only **3 members** each from the **top teams** shall be eligible to participate in the International rounds. Teams that have up to 5 members in the India National rounds cannot claim the right to participate in the International rounds for the additional members. Teams are required to mention clearly the name of the additional members in the registration form. Please read International Round Rules carefully.
- d. Only two team members may present arguments or otherwise participate in any particular round (all three may argue during the competition, but only two may argue in any particular round).
- e. Institutions that are using the Stetson 2021 - 22 Compromis in the selection rounds for choosing the participants of India National rounds may inform the National Administrator about the number of teams / members that participated in the selection rounds.

**6. Rounds**

- i. **Prelims:** Every team will argue at least once for Applicant as well as Respondent in the preliminary rounds. Memorial marks will be added to oral marks only in the preliminary rounds (both). The sixteen highest-ranking teams from the Preliminary Rounds will advance to the Octa final Rounds. The advancement to Octa / quarter final will be decided on
  - a. Win points
  - b. Win points + Aggregate
  - c. Win points + aggregate (in case of tie minus memorial marks)
- ii. **Octa / Quarter / Semi Finals:** The teams will be power protected. The highest-ranking team will argue against the lowest-ranking team. The highest ranking teams will pick lots for choosing the side of argument.

The time limit is 30 minutes per team for Preliminary, Octa final & Quarter final and 45 minutes per team for Semi Finals and Final round. The time covers oral arguments and rebuttal. The Octa, quarter and semifinal rounds are knockout rounds.

## 7. Oral argument

- i. The Judges will NOT announce the results after each oral round. They may be requested to provide a short oral critique at the end of each round
- ii. The administrator(s) will announce the result shortly after the completion of all preliminary rounds. Results of the Octa Final / Quarter Final / Semi Final rounds will be announced shortly after the rounds. The final results and the winners of different categories of prizes will be announced only during the Valediction ceremony.
- iii. For Best Student Advocate award points scored from preliminary rounds alone will be counted.

## 8. Judges

There will be a minimum of two judges for the preliminary / Octa final / Quarter final rounds. In the absence of the Third judge the average marks of the two judges would be the score of the third judge. There will be a minimum of 3 judges for the Semi Finals and Final

## 9. Memorials

- i. The rules concerning the memorials format and page / word limit are same as that of the International Rounds, which can be found in the International rules and regulations available at <http://www.stetson.edu/law/international/iemcc/index.php>
- ii. Memorials(soft copy) should have front and back covers as follows (for India National rounds):  
Applicant – Light Blue cover;                      Respondent – Light Red cover.
- iii. Late submissions will attract penalty of 1 point per memorial for each day of delay.
- iv. Soft copies of both Applicant & Respondent memorials (only 2 complete files containing all parts of memorials) is to be sent by e-mail latest by **12<sup>th</sup> November 2021, 5.00 p.m. EST (Eastern Standard Time)** for purpose of evaluation in MS Word format to [kpratt2@law.stetson.edu](mailto:kpratt2@law.stetson.edu) with a copy to [mootcourt@lawindia.com](mailto:mootcourt@lawindia.com)
- v. Soft copies of both Applicant & Respondent memorials to be submitted on registration (only 2 complete files containing all parts of memorials) and is to be sent by e-mail latest by 10th December 2021 for purpose of evaluation in MS Word format to [stetsonindia@jgu.edu.in](mailto:stetsonindia@jgu.edu.in) with a copy to [mootcourt@lawindia.com](mailto:mootcourt@lawindia.com).
- vi. No changes may be made to any written pleading once it has been submitted to a Regional Round. A written pleading submitted to the International Finals must be an exact copy of the written pleading submitted to the Regional Round.
- vii. Memorial scores will be added to the individual oral scores during the preliminary rounds for declaring the winners. Memorial scores will not be added at the knockout stage. (Octa Final, Quarter Final, Semi Final & Final)

## 10. Registration

- i. Online registrations will be open from **8<sup>th</sup> November 2021**. Teams must provisionally **register online** latest by **12<sup>th</sup> November 2021 (5.00 pm IST)** at [www.moot.in](http://www.moot.in). Participants will receive a system generated acknowledgement as provisional confirmation of their online registration from time to time as and when they register. **There is no registration / participation fee for Surana & Surana India National Rounds.** A scanned / soft copy of the registration form/

approval letter as per the format provided in the rules is required to be uploaded during the online registration process. The letter must contain names, year/semester of study of the participants. **The forms need not be signed by any of the authorized signatories for the provisional registration** from your law school/ college/ university / institution. Team code will be allotted to you which can be used for submission of memorials to Stetson.

- ii. A scanned copy of the approval letter duly signed by any of the following: Faculty-in-charge of MCS/MCA, Registrar, Principal, Dean, Director, Chancellor or Vice-Chancellor on the letter head of the participating college / institution / University is required to be emailed to [mootcourt@lawindia.com](mailto:mootcourt@lawindia.com). The letter or email emanating from the official email id of your law school/college/institution/university must contain names, year/semester of study of the participants. Alternatively, teams may get the signature of any of the aforementioned persons under their official seal on the registration form itself appended below.

Registrations with the authorized signatory attestation on form/letter or email emanating from official email id from the college / institution / University is only valid for participation in the India national Rounds. **Only at the completion of this process will teams be finally registered and receive an approval of registration.**

- iii. In addition to the online registration as mentioned above, teams must ensure that duly filled in scanned form/letter is electronically mailed to **Jindal Global Law School, Sonipat, Haryana**, latest by **10th December 2021** with subject "SURANA & SURANA-STETSON MOOT 2021 - 22 REGISTRATION".
