### RULES AND REGULATIONS

#### I. VENUE, DATE & SUBJECT MATTER:

The 7<sup>th</sup> Surana & Surana International Moot Court Competition shall be held from 2 - 4 February 2008 at Symbiosis Law School, Pune. This year's case is in the evolving area of **Augmented Reality** and related issues. Any clarification sought in respect of the case should be addressed by email to mootcourt@lawindia.com **before 31 December 2007**. No clarification will be issued after this date.

#### II. THE COMPETITION SHALL BE IN ENGLISH LANGUAGE.

#### III. ELIGIBILITY:

The competition is open only for students who are studying for LLB three year or five year course during the current academic year. To augment technology related research a team have the option of having one student member (must be an undergraduate) from technology / science discipline (other than law), from any institution approved by the HOD or the Head of the Institution.

#### IV. TEAM COMPOSITION:

- a. The team should consist of three members (including the technology science student member) i.e two speakers and one researcher and this number cannot be modified under any circumstances. The teams or their respective sponsoring institution shall meet their traveling expenses.
- b. The researcher cannot be allowed to speak except under special cases and only with the express permission of the Administrator.
- c. Each team will have a code and individual participants will also be given the code numbers.
- d. The identity of the team must not be disclosed to the judges. Any such disclosure will lead to disqualification.
- e. In order to encourage law schools from remote parts of India, Surana & Surana Public Charitable Trust contemplates reimbursing sleeper class – Non A/c train fare (to & fro) to three members of teams participating from remote areas of Arunachal Pradesh, Assam, Bihar, Chattisgarh, Haryana, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Madhya Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Orissa, Tripura and Uttaranchal. The head of the institutions **must forward applications in advance** to The Administration Officer, Surana & Surana Public Charitable Trust, 224 NSC Bose Road, Chennai 600 001. The teams must first participate and then claim the reimbursement

#### V. REGISTRATION:

The teams must register by **31 December 2007**, and if there are to be any changes in the team composition in terms of the members participating then the organizers must be informed by **22<sup>nd</sup> January 2008** at the latest.

Manupatra, Knowledge Partner to the Moot Court Competition has extended free use of its legal database for research to the members of the team who register for the competition 21 days or earlier. On registration, the teams will be forwarded a User ID and Password.

#### VI. ROUNDS:

There will be two preliminary rounds of arguments, a quarterfinal, a semi-final and one final round.

##### **Preliminary Round**

- a. There will be two preliminary rounds of arguments per team, once for applicant & another for respondent.
- b. No team will face each other more than once in the preliminary rounds.
- c. Each team will face a different bench in their second round of arguments.

- d. Preliminary Rounds will be held on 3<sup>rd</sup> February 2008 (Sunday), in two sessions (Pre-Lunch and Post-Lunch) and the top eight scorers, will qualify for the quarterfinals to be held on 4<sup>th</sup> February 2008 (Monday morning).
- e. Top eight teams will be selected on the basis of rounds won (two wins). In case of tie, then total of preliminary round scores will be taken. (The team with highest scores in preliminary round will advance to quarterfinals)
- f. Lots will be drawn on 2<sup>nd</sup> February 2008 evening at 4.30 p.m. and separate codes and side will be allotted. The Registration and Orientation will also be conducted the same evening.

#### **Quarterfinal / Semi Final Round / Final Round:**

Lots picked by the teams will decide the side of the arguments in Quarterfinals, Semi finals & Finals. Quarterfinals will take place at 8.00 a.m. on Monday 4<sup>th</sup> February 2008 (could be preponed to 3<sup>rd</sup> February 2008 evening depending on circumstances). The top four teams will proceed to semifinals to be held thereafter. The Finals will be held post lunch at 2.00 p.m. The Quarterfinals/Semifinal are knockout rounds.

#### **Results**

Results will be announced within 30 minutes after the completion of the preliminary / quarter / semifinal rounds. The Final result and the winners of the various categories will be announced only during the valediction / prize distribution ceremony.

#### **VII. BENCHES:**

Preliminary round, quarterfinal and semifinal bench will comprise of two judges and the final round bench will comprise of three judges.

#### **VIII. MEMORIALS:**

The following requirements for memorials must be strictly followed. Non-conformities will be penalized.

- a. Each team must prepare memorials for both parties to the dispute.
- b. One hard copy of both the memorials + one soft copy on CD for each side (both applicant and respondent must be in the same CD) must reach the organizers by **22 January 2008** latest by 5.30 p.m. Memorials / Amendments to the memorials shall not be accepted after. **22 January 2008**. The remaining 5 hard copies may be submitted during registration / orientation.
- c. The memorials have to be submitted on typed A4 size white paper and must contain:
  - The table of contents
  - The index of authorities
  - The statement of jurisdiction
  - The statement of facts (1 page only and submissions of an argumentative statement of facts would attract penalties)
  - The statement of issues
  - The summary of pleadings (not more than one page)
  - The arguments advanced (not more than fifteen pages)
  - The prayer
- d. The soft copy of the memorial for each side shall be a single file and in MS-Word. It shall correspond with paper memorial. There should be only **two word documents** (containing all details), one for Applicant and the other for the Respondent. (Separate first page / list of abbreviations / appendix / Table of contents etc. are not allowed).
- e. The pleadings must not exceed 15 (fifteen) pages. The font size should 12 and for footnotes it should be 10. Acceptable font shall be Roman or Times new Roman. Blue Book pattern should be followed.
- f. The memorial must have a margin measuring one inch on all sides of each page. Margin should be left blank i.e., no margin notes, boundaries etc.

- g. The page numbering should be on the top right side of each page.
- h. The applicant / respondent memorials must be differentiated by light blue covers for applicant and light red covers for respondent.
- j. The cover page of the memorial must state the following:
  - Title stating the same is a brief of the applicant or the respondent, as the case may be.
  - The cause title
- k. Identification of any type shall not be revealed anywhere inside the memorial.
- l. This moot is an environment friendly moot hence use of plastic binding is prohibited.. Memorials should be stapled by not more than 3 staples on the left hand side or stitched by cotton thread. Teams are advised not use spiral or comb binding.

#### IX. ORAL ROUND:

##### **Preliminary & Quarter Final**

- a. Each team will get a total of 30 minutes to present their case. This time will include rebuttal and sur-rebuttal
- b. The division of time is at the discretion of the team members, subject to a maximum of 15 minutes per speaker. Division of time shall be informed to the court officer before arguments.
- c. The oral arguments need not be confined to the issues presented in the memorials.
- d. The researcher shall sit with the speaker at the time of orals.

##### **Semi Final & Final Round:**

- a. Each team will get a total of 45 mts. This time will include rebuttal and sur-rebuttal
- b. The division of time is at the discretion of the team members, subject to a maximum of 25 mts. per speaker.
- c. The oral arguments need not be confined to the issues presented in the memorials.
- d. The researcher shall sit with the speakers at the time of the orals.

#### X. SCOUTING:

The teams will not be allowed to observe the orals of any other teams. Scouting is strictly prohibited. Scouting by any of the team's members will result in disqualification.

#### XI. SCORING:

##### A. Orals:

The criteria for marking the orals are:

- a. Knowledge of the facts.
- b. Proper and articulate analysis of the issues arising out of the facts.
- c. Understanding of the international / national legal principles directly applicable to the issues.
- d. Ability to explain clearly international / national legal principles in general keeping to the time allotted.
- e. Knowledge and use of legal sources: treaties, custom, general principles of international / national laws.
- f. Ingenuity (ability to argue by analogy from related aspects of international/ national law.
- g. Logic and reasoning.
- h. Organization and clarity.
- i. Persuasiveness.
- j. Deference to the court.

##### B. Written Submissions (Memorials)

The criteria for marking the memorials are:

- a. Presentation - (the categories listed under XI (d) to XI (j) will be marked under this heading)
- b. Quality of arguments.

- c. Formatting and Syntax.

## XII. AWARDS:

- a. Best Team Award is a Rolling Trophy and a cash prize of Rs 18,000/- only
- b. Second Best Team will be given a cash prize of Rs. 9,000/- only
- c. Best Memorial Award- a cash prize of Rs 4,000/- only
- d. Second Best Memorial Award – a cash prize of Rs.2000/- only
- e. Best Speaker Award - a cash prize of Rs. 4,000/- only
- f. Second Best Speaker Award – a cash prize of Rs. 2000/- only

In addition to the above awards plaques and certificates are given to other categories of winners

All participants will be awarded participation certificates.

## XIII. DECISION OF THE JUDGES IS FINAL.
