



**OFFICIAL RULES FOR THE SURANA & SURANA INDIA ROUNDS OF
THE 30TH STETSON INTERNATIONAL ENVIRONMENTAL MOOT COURT COMPETITION - 2025-26

**The Surana & Surana India Rounds Will Be Conducted On Campus (In Person). The India Rounds
Administrators Reserves The Right To Modify Or Supplement The Rules For Any Reason.**

1. These rules (modified to an extent from the rules of International rounds) shall be the official rules for the Surana & Surana India Rounds of the 30th Stetson International Environmental Moot Court Competition - 2025-26. The **India rounds** rules are complementary to the International Rules. Details not specifically mentioned may be referred from the International rules.
2. However, for advancing the top teams to the International Finals from the **India Rounds** Organizing Committee are guided by the INTERNATIONAL RULES ONLY. The said rules may be downloaded from <http://www.stetson.edu/law/international/iemcc/>
3. The 2025-26 Stetson (**India Rounds**) will have teams from **India & Nepal**.
4. The “**Surana & Surana India Rounds - 30th Stetson International Environmental Moot Court Competition**” is an **In Person** round to be held at the campus of **School of Law, Christ (Deemed to be University), Dharmaram College Post, Hosur Road, Bengaluru 560 029, Karnataka, India**.
5. The competition will be held in **English language**.
6. **Team Composition**
 - a. Each team can have two speakers and one researcher. Not more than two additional members (total 5) may be part of a team. Additional members will not participate in the proceedings. All members will be awarded participation certificates. **Additional members will be given only participation certificates, even if their teams win in any category.**
 - b. Team Participating in the **India Rounds** from the Host School will be guided by Rule **B. 1 (e)** of the International Rules.
 - c. **IMPORTANT** - Only **3 members** each from the **top teams** shall be eligible to participate in the International rounds. Teams that have up to 5 members in the **India Rounds** cannot claim the right to participate in the International rounds for the additional members. Teams are required to mention clearly the name of the additional members in the registration form. Please read International Round Rules carefully.

- d. Only two team members may present arguments or otherwise participate in any particular round (all three may argue during the competition, but only two may argue in any particular round).
- e. Institutions that are using the Stetson 2025-26 Compromis in the selection rounds for choosing the participants of **India Rounds** may inform the Administrators about the number of teams / members that participated in the selection rounds.

(Refer to IEMCC Rules J. MISCELLANEOUS 1. Use of Problem)

7. Rounds

- i. **Prelims:** Every team will argue at least once for Applicant as well as Respondent in the Preliminary rounds. Memorial score will be added to the Oral score in both the Preliminary rounds only. The sixteen / eight highest-ranking teams from the Preliminary Rounds will advance to the Octa Final / Quarter Final Rounds.

The advancement to Octa / Quarter Final will be decided on

- a. Win points
 - b. Win points + Aggregate
 - c. Win points + aggregate (in case of tie minus memorial scores)
- ii. **Octa / Quarter / Semi Finals:** The teams will be power protected. The highest-ranking team will argue against the lowest-ranking team. The highest-ranking teams will pick lots for choosing the side of argument.

The time limit is 30 minutes per team for Preliminary, Octa final & Quarter final and 45 minutes per team for Semi Finals and Final round. The time covers oral arguments and rebuttal. The Octa, Quarter and Semi Final rounds are knockout rounds.

8. Oral argument

- i. The Judges will **NOT** announce the results after each oral round. They may be requested to provide a short oral critique at the end of each round
- ii. The administrator(s) will announce the result shortly after the completion of all Preliminary rounds. Results of the Octa Final / Quarter Final / Semi Final rounds will be announced shortly after the rounds. The Final results and the winners of different categories of prizes will be announced only during the Valediction ceremony.

- iii. For Best Student Advocate award points scored from Preliminary rounds alone will be counted.

9. Judges

There will be a minimum of two judges for the Preliminary / Octa Final / Quarter Final rounds. There will be a minimum of 3 judges for the Semi Finals and Final. In the absence of the Third judge the average marks of the two judges would be the score of the third judge.

10. Memorials

- i. The rules concerning the memorials format and page / word limit are same as that of the International Rounds, which can be found in the International rules and regulations available at <http://www.stetson.edu/law/international/iemcc/>
- ii. Memorials (soft copy) should have front and back covers as follows (for **India Rounds**) :
Applicant - Light Blue cover ; Respondent - Light Red cover.
- iii. Each memorial must include the following sections, in the order listed : front cover page, table of contents, index of authorities, questions presented, statement of jurisdiction, statement of facts, summary of argument, argument with point headings, conclusion, signature block and affidavit.
- iv. Late submissions will attract penalty of **3 points** per memorial for each day of delay.
- v. Soft copies of **either** Applicant **or** Respondent memorials are required to be submitted (complete files containing all parts of memorials) is to be sent by e-mail latest by **17th November 2025, 5.00 p.m. EST (Eastern Standard Time) equivalent to 18th November 2025, 2.30 a.m. IST (Indian Standard Time)** for purpose of evaluation in MS Word (.doc or .docx) format to kpratt2@law.stetson.edu with the subject line “**2026 IEMCC Memorial XXXX**” - **India Rounds** (where XXXX is the team’s assigned identification number, **Refer Clause 13 i**) along with a signed affidavit (**refer Addendum A of the International Rules**) which is supposed to be in a separate file from the memorial but attached to the same eMail with a copy to ai@lawindia.com .
- vi. Soft copies of **both** Applicant & Respondent memorials for the **India Rounds** is to be submitted on registration (only 2 complete files containing all parts of memorials) and is to be sent by e-mail latest

- vii. No changes may be made to any written pleading once it has been submitted to INDIA Round. A written pleading submitted to the International Finals must be an exact copy of the written pleading submitted to the INDIA Rounds.
- viii. Memorial scores will be added to the individual oral scores during the Preliminary Rounds for declaring the winners. Memorial scores will not be added at the knockout stage. (Octa Final, Quarter Final, Semi Final & Final)

11. Live Streaming of the Finals

The organisers will arrange for the live streaming of only the finals of the competition through the YouTube link to be provided by Surana & Surana.

12. Decision of the Judges will be Final and Binding in all

13. Registration

- i. Online registrations will be open from **12th October 2025**. Teams must **register online** latest by **16th November 2025** at www.moot.in. Participants will receive an approval as confirmation of their online registration & participation from time to time as and when they register. Participants will be allotted an Identification number or Team code once registration is approved which will be used for Submission of Memorials.
- ii. A scanned copy of the approval letter duly signed by any of the following: Faculty-in-charge of MCS/MCA, Registrar, Principal, Dean, Director, Chancellor or Vice-Chancellor on the letter head of the participating college / institution / University is required to be uploaded during the online registration process. The letter must contain names, year / semester of study of the participants. Alternatively, teams may get the signature of any of the aforementioned persons under their official seal on the registration form itself appended below. Registrations without the registration form / approval letter from the college / institution / University as mentioned above is not valid. Only one approved team from a college / institution / University would be eligible to participate.

- iii. In light of the Competition's interest in encouraging greater participation and subject to approval of the **India Rounds** coordinator and the Competition Committee, a single team may consist of students from different schools. (Refer to IEMCC Rules C. Team Composition), subject to any / other additional team would not register & participate from the particular / same institution. i.e., students from same institution shall not be allowed to participate in two different teams.
- iv. In addition to the online registration as mentioned above, teams must ensure that duly filled in scanned form / letter is electronically mailed to Host institution latest by **16th November 2025** with subject *"SURANA & SURANA INDIA ROUNDS - 30TH STETSON INTERNATIONAL ENVIRONMENTAL MOOT COURT COMPETITION 2025-26 REGISTRATION"* stetson.slcu@law.christuniversity.in with a copy to ai@lawindia.com.

14. International Finals

The Top Three or more teams (from India Rounds) subject to the fulfillment criteria of the International Rules and as approved by the Competition Committee, Stetson IEMCC based on number of participants will represent the International finals from April 15th - April 18th, 2026 at Stetson University College of Law, 1401 61st Street South, Gulfport, Florida 33707, USA.

15. Registration Fee

- a. All teams wishing to participate in the **India Rounds** shall be required to pay a base registration fee of **Rs. 4,500 (Rupees Four Thousand Five Hundred Only)** on or before **16th November 2025**.
- b. The Registration Fee is to be paid through any of the option given below:

- c. Payment reference number, date of payment must be mentioned and a scanned copy of the payment receipt also have to be attached and sent to stetson.slcu@law.christuniversity.in . Only then will the registration be deemed to be complete.

16. Accommodation & Transport for India Rounds

- a. Accommodation will be provided by School of Law, Christ (Deemed to be University), Bangalore, only during the period of the Competition i.e., **Jan 8, 2026 (2.00 pm IST) till Jan 11, 2026 (5.00 pm IST)**.
- b. The name and mobile number of the student volunteers in charge of transport / accommodation will also be made available after finalization. Teams should fill in their travel plan in the sheet available on **ANNEXURE B** positively and send the scanned copy by **5.00 PM on 1st December, 2025** via email stetson.slcu@law.christuniversity.in
- c. Separate lodging arrangements for boys & girls shall be strictly enforced in the allocated rooms. However, common areas will be available for all participants to utilize for preparation purposes.
- d. To facilitate convenient travel, shuttle services will be provided to transport participants between their designated accommodation and the college campus. The specific schedule and pick-up / drop-off locations for the shuttle services will be communicated to registered participants closer to the competition date.
- e. Extra members over and above the prescribed number of upto 5 members will not be entertained and accommodated under any circumstances.
- f. *Misbehavior of any sort by the participants will be dealt very seriously and will lead to disqualification.*

17. Administrators

The Administrators' decision shall be final in all matters concerning the competition.
